In exercise of the powers conferred by Clause (2) of Article 229 of the Constitution of India, the Hon'ble, the Chief Justice is hereby pleased to make the following Rules to further amend the Sikkim High Court Computer Cadre Service Rules, 2013; namely,-

# 1. Short title, commencement and application:

- (i) These Rules may be called the Sikkim High Court Computer Cadre Service (Amendment) Rules, 2023.
- (ii) They shall come into force on the date of their publication in the official gazette.

## 2. Amendments in the Schedule I, I 'A', II and II 'A':

- (i) In the **Schedule-I** of Sikkim High Court Computer Cadre Service Rules, 2013, for the figure **"02"** appearing in Column 3 below the heading **"No. of permanent Posts"**, against entries at Sl. No. 1, the figure **"03"** shall be substituted.
- (ii) In the Schedule-II of Sikkim High Court Computer Cadre Service Rules, 2013, for the figure "02" appearing in Column 3 below the heading "No. of Posts", against entries at Sl. No.1, the figure "03" shall be substituted.
- (iii) The Schedule I'A' & II 'A' shall be substituted with the following new Schedules I'A' & II 'A':-
