1. Sikkim Judicial Academy (*hereinafter referred as the 'Academy'*) invites tenders for the supply and installation of Audio-Visual and Lighting Equipment at Sikkim Judicial Academy.

- 2. The Bidder shall deposit Rs. 1,00,000/- (Rupees one lakh only) as Earnest Money Deposit (EMD) by means of Demand Draft in the name of Director, Sikkim Judicial Academy. Tender submitted without the prescribed EMD will be rejected, and in case of refusal by the successful bidder to perform the required services, earnest money will be forfeited.
- 3. The rates to be quoted shall include all applicable taxes. No amount above the bid will be paid by the Academy to the bidder in addition to the rates quoted.
- 4. The rates quoted should be inclusive of the transit insurance up to the destination and it shall be at the cost of the tenderer.
- 5. The items to be delivered must conform/bear the mark of Bureau of Indian Standards (BIS) and other equivalent standards.
- 6. The safety of the items to be delivered on site, as well as its installation, shall be the sole responsibility of the bidder.
- 7. The decision of the Academy shall be final and binding with regard to the bid. All pages of this Tender Document will have to be submitted duly signed and

- sealed by Bidder after due consideration of the Terms and Conditions prescribed herein.
- 8. The Academy reserves the right to accept or reject any or all tenders, in whole or in part, from any bidder without assigning any reason whatsoever.
- 9. The Academy shall reserve the right to change/modify/amend any/all provisions of the tender documents.
- 10. The quantities mentioned in Annexure III are indicative in nature. They may increase or decrease while placing the supply order.

## **Scope of Work**

- 11. The successful bidder shall supply, install, configure, and demonstrate the working of all equipment as per the specifications provided in Annexure III.
- 12. The Academy will have the option to terminate the services after giving a notice of one month in writing without assigning any reason, if the successful bidder commits breach of any of the conditions contained in the tender or fails to render services to the satisfaction of the Academy.
- 13. The successful bidder may choose to forfeit the service by giving two months prior notice in writing. However, the sole discretion of forfeiture lies with the Academy. The alteration done to the infrastructure, if the notice is given midway, shall be returned to its original form at the expense of the successful bidder.
- 14. The successful bidder shall provide an adequate numbers of competent and well-trained workers for quick and proper supply and installation.
- 15. The successful bidder must complete the supply and installation within 60 days from the date of issue of the work order.
- 16. A penalty of Rs. 1000/- (Rupees one thousand only) per day will be levied for any delay beyond the stipulated completion period.
- 17. The successful bidder shall have full control on his/her/their employees and shall give necessary guidelines and instructions to carry out the job assigned to them.
- 18. Residential accommodation shall not be provided by the Academy to the workers of the successful bidder.

- 19. The successful bidder shall ensure all safety precautions during the installation. Any damage caused to the existing infrastructure or personnel during the execution of work shall be the responsibility of the bidder.
- 20. The successful bidder or his/her/their staff shall not use the premises of the Academy for any other purpose apart from those related to the supply, installation, commissioning and testing of the system.
- 21. The successful bidder shall furnish the list of his/her/their employees, along with their credentials, to be deployed at the Academy.
- 22. The successful bidder shall take prior permission from authorized officials of the Academy before deploying any employee at the Academy. However, the Academy reserves the right to reject any worker/staff employed by the bidder under the bid with the Academy, without assigning any reason.

### **Eligibility Criteria**

- 23. Those bidders with prior experience in similar audio-visual and lighting system installations (proof/documentation to be attached) only are to apply for the tenders.
- 24. Bidders are required to submit a valid Manufacturer's Authorisation Form (MAF) from the Original Equipment Manufacturer (OEM) for each of the equipment offered in the tender. Bids submitted without the MAF shall be summarily rejected.
- 25. Tender documents should be duly filled and signed by the bidder on each page, embossed with the proprietor's official seal.
- 26. Tender received late on account of any reason whatsoever shall not be entertained.
- 27. The bidder must be an authorised supplier/installer of electrical equipment (Documents in this regard are to be enclosed with the tender documents).
- 28. The bidder must have valid GST registration, Trade License, and PAN card.

# **Terms of Payment**

- 29. Payment shall be released after successful installation, commission, and testing of the system, certified by the competent authority of Sikkim Judicial Academy.
- 30. No advance payment shall be made.

# **Disputes Resolution**

- 31. All disputes arising under this agreement shall be settled amicably through discussions between the parties.
- 32. In case of any unsettled disputes, the same shall be referred to the Arbitrator appointed by the Academy. The place of arbitration shall be at Gangtok. The provisions of the Arbitration and Conciliation Act, 1996 shall be applicable to such proceedings and the decision of the Arbitrator shall be final and binding on both the parties.

### **Warranty and Maintenance**

- 33. The system and its components must carry a minimum warranty of 24 months from the date of commission.
- 34. Any defects arising during the warranty period should be rectified as soon as possible and free of cost by the successful bidder.
