EMPLOYMENT NOTICE

Applications are invited from eligible candidates for filling up the following Group 'C' and 'D' posts in the Establishment of the High Court of Sikkim, on purely temporary basis, as under:-

Sl. No.	Name of the post	Pay Scale	No. of vacancy	Method of Selection	Eligibility Conditions
1.	Bus Driver (Group 'C')	Level-6 of the Pay Matrix	1(one)	By direct recruitment through driving test followed by interview/viva- voce	Candidates should be Class V passed and should also possess a valid licence in driving heavy vehicles with a minimum experience of 3(three) years in driving heavy vehicles.
2.	Peon (Group 'D')	Level-4 of the Pay Matrix	1(one)	By direct recruitment through interview/viva- voce.	Candidates having minimum educational qualification of Class VIII passed from a recognized School/ Board
3.	Residential Orderly (Sevak/Cook) (Group 'D')	--do--	4(four)	By direct recruitment through interview/viva- voce.	Candidates having minimum educational qualification of Class V passed from a recognized School/ Board.

2. A candidate for appointment to the above posts must be:-

(a) a citizen of India; and

(b) not less than 18 years of age as on the first day of January of the recruitment year and not more than 40 years of age on the last day of submission of application Form, which shall be uniform age for all communities of the State in the services/posts to be filled up by direct recruitment. Relaxation of upper age limit shall be the same as may be prescribed by the State Government from time to time.

3. Candidates fulfilling the above conditions may apply for the post(s) along with all the supporting documents, duly attested and 3(three) recent passport size photographs, to the undersigned. Applications received without supporting documents and photographs will be summarily rejected. Candidates are also required to mention their proper address and mobile/contact numbers in their applications.

4. The last date for receipt of applications is **23.11.2019**.
5. Applications received after the last date **23.11.2019** shall not be entertained on any ground.
6. Those who are already in Government service shall apply through proper channel.
7. Candidates found eligible on preliminary scrutiny of the applications shall be issued admit cards for appearing in the driving test and interview/ viva-voce, as the case may be. **The list of names of candidates found eligible on preliminary scrutiny will be displayed on the Notice Board of the High Court of Sikkim and/or the eligible candidates will be intimated through SMS in their mobile numbers. Therefore, furnishing of mobile numbers by the candidates in their application is mandatory.**
8. Date(s) of issuance of Admit Cards to the eligible candidates will be intimated later on through SMS and by way of publication in the local dailies, as the case may be, along with the date, time and venue of driving test and interview/ viva-voce.
9. The Registry of the High Court of Sikkim reserves the right to accept or reject any application, with or without assigning any reason.
10. Please note that no separate calling letters will be issued to the eligible candidates for appearing in the driving test and interview/viva-voce, as the case may be.
11. No T.A./D.A. shall be paid for appearing in the driving test and interview/viva-voce.
