GANGTOK, April 1: The Case Information System (CIS) for High Courts was launched by Supreme Court of India Judge Justice Arjan Kumar Sikri on Saturday.

The launching was done during a 'regional conference for enhancing the excellence of judicial institutions: challenges & opportunities (east zone-II) here at Chintan Bhawan.

GANGTOK, April 1: Supreme Court Judge Justice Arjan Kumar Sikri has observed that role of judges is not just to deliver judgment on cases but also to strength the judicial system.

He was speaking at the inaugural session of a two-day 'regional conference for enhancing the excellence of judicial institutions: challenges & opportunities (east zone-II) here at Chintan Bhawan. It was organised by National Judicial Academy, Bhopal in coordination with the High

Court of Sikkim and Sikkim Judicial Academy.

"Dispensing justice is the fundamental duty of the judge but another responsibility is to strengthen and enhance the judicial system. The faith of people in judiciary is the power and strength which has to be maintained and taken to new pedestal by the judges," remarked Justice Sikri.

He said people's faith in the judiciary should not be diminished for which the judicial system has to work more effectively to give quality justice. Quality justice includes delivery of good



judgment by upholding the Constitution and rule of law, he mentioned adding that judges should bridge the gap
