NOTIFICATION

Guidelines for transfer of Judicial Officers

In supersession of the "Guidelines" for general transfer of Judicial Officers dated 05.03.2019, issued by the then Registrar General and all "Guidelines" issued previous thereto, the following "Guidelines" for general transfer of Judicial Officers shall come into immediate effect:-

- 1. General transfer of Judicial Officers shall be effected by the Full Court for effective administration of justice and for public interest;
- Usual tenure of posting of Judicial Offices at any place other than the Registry

 shall be for a maximum period of 3 (three) years. In the event of any Judicial
 Officer being posted in the Registry, his/her tenure shall be determined solely by
 the Hon'ble, the Chief Justice;
- 3. A Judicial Officer at any point of time may be prematurely transferred or may be retained after the expiry of 3 (three) years at his/her place of posting at the sole discretion of the Hon'ble, the Chief Justice;
- 4. In the usual course of business, general transfer of Judicial Officers within the State shall be effected each year, preferably in the month of April/May and
- 5. For matters that have not been specifically provided herein, the Hon'ble, the Chief Justice, may issue such further general or specific directions/clarifications as may be necessary in order to make this general transfer policy efficacious.
