#### NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India the Governor of Sikkim in consultation with the High Court of Sikkim hereby makes the following rules further to amend the Sikkim Subordinate Courts' Service (Method of Recruitment and Conditions of Service) Rules, 2001, namely;-

#### Short title and Commencement

1.

- These rules may be called the Sikkim Subordinate Courts' Service (Method of Recruitment and Conditions of Service) Amendment Rules, 2015.
  - (2). They shall come into force at once.
- 2. In the Sikkim Sub-ordinate Courts' Service (Method of Recruitment and Conditions of Service) Rules, 2001, (here-in-after referred to as the said rules), in clause (h) of rule 2, for the word and alphabet "Appendix E", the word and alphabet "Schedule O" shall be substituted.
- 3. In the said rules, in sub-rule (1) of rule 9, for the word and alphabet "Appendix E", the word and alphabet "Schedule O" shall be substituted.
- In the said rules, in sub-rule (1) of rule 11, after the words "Subordinate Courts" and before the words "in such manner", the word "inter-se" shall be inserted.
- 5. In the said rules, the existing word and alphabets "Appendixes A to F", the word and alphabets "Schedule A to F" shall respectively be substituted.
- In the said rules, after Schedule N the following new "Schedule O" shall be inserted, namely:-
