In exercise of the powers conferred by Clause (2) of Article 229 of the Constitution of India, Hon'ble the Chief Justice is hereby pleased to make the following rules, to further amend the Sikkim High Court Computer Cadre Service Rules, 2013; namely,-

1. Short title, commencement and application:

- (i) These Rules may be called the Sikkim High Court Computer Cadre Service (Amendment) Rules, 2018.
- (ii) They shall come into force on the date of their publication in the Official Gazette.

(a) Amendment of Schedule-I:

In the Sikkim High Court Computer Cadre Service Rules, 2013, Schedule I, **Column No.3** under the head: "**Number of Permanent Posts**", the existing figure '1' for the post of Senior System Officer appearing at Sl. No.1, shall now be substituted by the figure '2'.

(b) Amendment of Schedule-II:

In the Sikkim High Court Computer Cadre Service Rules, 2013 **Schedule-II, Column No.3** under the head: "**Number of Posts**", for the existing figure '1' for the post of Senior System Officer appearing at Sl. No.1 shall now be substituted by the figure '2'.
